ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the B3-1, Community Shopping District symbols as shown on Map No. 9-P in the area bounded by:

The public alley next North of and parallel to West Addison Street; a line 100 feet East of and parallel to North Pontiac Avenue; West Addison Street; a line 75 feet East of and parallel to North Pontiac Avenue.

To those of a B2-2, Neighborhood Mixed-Use District

SECTION 2. This Ordinance takes effect after its passage and due publication.
