Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to FLETCHER JONES VOLKSWAGEN, upon the terms and subject to the conditions of this ordinance to maintain and use nine (9) sign(s) projecting over the public right-of-way attached to its premises known as 1111 N. Clark St..

Said sign structure(s) measures as follows; along W. Maple Street:

One (1) at nineteen (19) feet in length, six point five eight (6.58) feet in height and forty-five (45) feet above grade level.

Said sign structure(s) measures as follows; along W. Maple Street:

One (1) at three point two five (3.25) feet in length, three point two five (3.25) feet in height and six (6) feet above grade level.

Said sign structure(s) measures as follows; along N. Clark Street:

One (1) at nineteen (19) feet in length, six point five eight (6.58) feet in height and forty-five (45) feet above grade level.

Said sign structure(s) measures as follows; along W. Maple Street:

One (1) at eight point one seven (8.17) feet in length, two (2) feet in height and twelve (12) feet above grade level.

Said sign structure(s) measures as follows; along W. Maple Street:

One (1) at twenty-four point one seven (24.17) feet in length, two (2) feet in height and twelve (12) feet above grade level.

Said sign structure(s) measures as follows; along N. Clark Street:

One (1) at eight point one seven (8.17) feet in length, two (2) feet in height and twelve (12) feet above grade level.

Said sign structure(s) measures as follows; along N. Clark Street:

One (1) at twenty-four point one seven (24.17) feet in length, two (2) feet in height and twelve (12) feet above grade level.

Said sign structure(s) measures as follows; along W. Maple Street:

One (1) at five (5) feet in length, point eight three (.83) feet in height and ten (10) feet above grade level.

Said sign structure(s) measures as follows; along W. Maple Street:

One (1) at five (5) feet in length, point eight three (.83) feet in height and ten (10) feet above grade level.

The location of said privilege shall be as shown on prints kept on file with the Department of

Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Transportation (Division of Project Development) and Zoning Department - Signs.

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1121868 herein granted the sum of one thousand three hundred seventy-five (\$1,375.00) per annum in advance.

A 25% penalty will be added for payments received after due date.


