BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B1-3 Neighborhood Shopping District symbols and indications as shown on Map No. 9-H in the area bounded by

North Lincoln Avenue; a line 125.37 feet northwest of West Belmont Avenue; a line southwest 77.32 feet to a line 77.49 feet south to West Belmont; a line 25 feet east and parallel to West Belmont; a line north 62.02 feet to a line 61.85 northeast to North Lincoln Avenue


to those of a C1-3 Neighborhood Commercial District.


SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about June 15, 2016, the undersigned will file an application for a change in zoning from B1-3 Neighborhood Shopping District to C1-3 Neighborhood Commercial District on behalf of the Applicant and property owner, Lincoln Belmont Retail Investors II, LLC, for the property located at and fronting on both 3210 N. Lincoln Avenue and 1612 W. Belmont Avenue, Chicago, Illinois 60657.

The applicant/property owner intends to use the existing subject commercial property for a massage and facial spa establishment. The licensed business will have approximately 3,200 square feet in commercial building space within the existing footprint of the property. A zoning change is needed to allow a massage establishment use of the property. No new building, no dwelling units, no parking will be built on the property.
