BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B3-2 Community Shopping District symbols and indications as shown on Map No. 3-H in the area bounded by

The public alley next north of and parallel to West Chicago Avenue; North Wood Street; West Chicago Avenue; a line 24 feet west of and parallel to North Wood Street,

to those of a B2-3 Neighborhood Mixed-Use District

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.



In accordance with the Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about June 10, 2016, I, the undersigned, will file an application for a change in zoning from a B3-2 Community Shopping District to a B2-3 Neighborhood Mixed-Use District on behalf of O & J Investments, LLC.

The applicant seeks a zoning amendment to a B2-3 Neighborhood Mixed-Use District in order to allow a residential dwelling unit to replace the existing doctor's office at the address of 810 N. Wood Street.

The applicant intends to use the subject property to allow a dwelling unit (rental unit) to replace a former doctor's office in an existing 3-story building of approximately 2970 square feet at 1800 W. Chicago Avenue/808-810 N. Wood Street. The proposed ground floor space to be converted is approximately 1800 square feet. The existing ground floor pharmacy of approximately 1170 square feet will not be changed. There are a total of 4 existing dwelling units (apartment rentals) on the 2nd and 3rd floors. 1 additional dwelling unit to 5 total requires the change in density to B2-3. No changes will be made to the building height. There is no parking available on this lot as the building is placed from lot line to lot line.

The applicant and property owner is O & J Investments, LLC, 1800 W. Chicago Avenue, Chicago, IL 60622. Members are James McFarlane and Osvaldo Feliciano.
