ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B3-5, Community Shopping District symbols as shown on Map No. 3-F in the area generally bounded by:

a line beginning at a point 114.07 feet north of West Goethe Street and extending east to a point 114.11 feet north of West Goethe Street; North Dearborn Parkway; West Goethe Street; and the alley next west of and parallel to North Dearborn Parkway

to those of a RM-5, Residential Multi-Unit District.


SECTION 2. This ordinance takes effect after its passage and due publication.

In compliance with the notice requirements for an Amendment to the Chicago Zoning Ordinance, please be informed that on or about June 22, 2016, an application for an Amendment to the Chicago Zoning Ordinance will be filed on behalf of 1300 Dearborn Property, LLC, the owner and Applicant, for the property commonly known as The Three Arts Club located at 1300 North Dearborn Parkway. The current use of the property is the RH Gallery.

The Applicant, 1300 Dearborn Property, LLC proposes to rezone the property from B3-5, Community Shopping District, to RM-5, Residential Multi-Unit District in accordance with the terms of a Restrictive Covenant dated August 16, 2013. The Restrictive Covenant was entered into by and between the Applicant; the North Dearborn Association, an Illinois not-for-profit corporation; Sutton Place Association, an Illinois not-for-profit corporation; Whitney Condominium Association, an Illinois not-for-profit corporation; and 1250 North Dearborn Street Condominium Association. The recently renovated landmark building will continue to be used by RH Gallery with a ground-floor restaurant.
