ORDINANCE

WHEREAS, the City of Chicago (the "City"), a home rule unit of government under Section 6(a), Article VII of the 1970 Constitution of the State of Illinois, has heretofore found and does hereby find that there exists within the City a serious shortage of decent, safe and sanitary rental housing available to persons of low and moderate income; and

WHEREAS, the City has determined that the continuance of a shortage of affordable rental housing is harmful to the health, prosperity, economic stability and general welfare of the City; and

WHEREAS, the City has certain funds available from a variety of funding sources ("Multi-Family Program Funds") to make loans and grants for the development of multi-family residential housing to increase the number of families served with decent, safe, sanitary and affordable housing and to expand the long-term supply of affordable housing, and such Multi-Family Program Funds are administered by the City's Department of Planning and Development ("DPD"); and

WHEREAS, DPD has preliminarily reviewed and approved the making of a loan to Midwest Limited Partnership, an Illinois limited partnership (the "Borrower") of which Holsten Real Estate Development Corporation, an Illinois corporation is the sole general partner, in an amount not to exceed \$2,100,000 (the "Loan"), to be funded from Multi-Family Program Funds pursuant to the terms and conditions set forth in <u>Exhibit A</u> attached hereto and made a part hereof; and

WHEREAS, pursuant to ordinances adopted by the City Council of the City on November 10, 1994 and May 17, 1995, the City made a loan on September 26, 1995 in the original principal amount of \$7,455,412 to the Borrower for the acquisition of the property located at 6 North Hamlin Avenue, Chicago, Illinois 60624 (the "Property") and the rehabilitation of the building and improvements located thereon, the repayment of which is secured by, among other things, that certain Junior Mortgage and Security Agreement on the Property recorded with the Cook County Recorder of Deeds as document number 95652456 (the "1995 City Mortgage"); and

WHEREAS, the 1995 City Mortgage is the second mortgage on the Property, subordinate to that certain first mortgage from the Borrower to Community Investment Corporation recorded as document number 95652455 securing a loan in the original principal amount of \$1,000,000, and senior to that certain third mortgage from the Borrower to the Chicago Low-Income Housing Trust Fund recorded as document number 95652457 securing a loan in the original principal amount of \$900,000 and that certain fourth mortgage from the Borrower to the Illinois Housing Development Authority recorded as document number 95652460 securing a loan in the original principal amount of \$500,000; and

WHEREAS, legal title to the Property is held by Chicago Title Land Trust Company, as Successor Trustee to LaSalle National Trust N.A., as Trustee under a Trust Agreement dated December 9, 1994 and known as Trust No. 119238, the sole beneficiary of which trust is the Borrower; now, therefore,

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. The above recitals are expressly incorporated in and made a part of this ordinance as though fully set forth herein.

SECTION 2. The Commissioner of DPD (the "Commissioner") and a designee of the Commissioner (collectively, the "Authorized Officer") are each hereby authorized, subject to approval by the Corporation Counsel, to enter into and execute such agreements and instruments, and perform any and all acts as shall be necessary or advisable in connection with the implementation of the Loan. The Authorized Officer is hereby authorized, subject to the approval of the Corporation Counsel, to negotiate any and all terms and provisions in connection with the Loan which do not substantially modify the terms described in Exhibit A hereto. Upon the execution and receipt of proper documentation, the Authorized Officer is hereby authorized to disburse the proceeds of the Loan to the Borrower. Prior to the closing of the Loan, the Authorized Officer is authorized to sign and submit a commitment letter or like document (including but not limited to copies of the proposed Loan documents) to the Borrower and/or the United States Department of Housing and Urban Development to evidence the City's intention to make the Loan.

SECTION 3. The Project (as described on Exhibit A hereto) shall be deemed to qualify as "Affordable Housing" for purposes of Chapter 16-18 of the Municipal Code of Chicago (the "Municipal Code"). Sections 2-45-110 and 2-45-115 of the Municipal Code shall not apply to the Project or the Property. Notwithstanding anything to the contrary contained in the Municipal Code any other ordinance or mayoral executive order, no parties other than the Borrower, any legal entities which are direct owners in excess of 7.5% of the Borrower which have changed in connection with the Loan, and all legal entities which constitute the direct or indirect controlling parties of the Borrower (as determined by the Corporation Counsel), shall be required to provide to the City the document commonly known as the "Economic Disclosure Statement and Affidavit" (or any successor to such document) in connection with the Loan.

SECTION 4. To the extent that any ordinance, resolution, rule, order or provision of the Municipal Code, or part thereof, is in conflict with the provisions of this ordinance, the provisions of this ordinance shall control. If any section, paragraph, clause or provision of this ordinance shall be held invalid, the invalidity of such section, paragraph, clause or provision shall not affect any of the other provisions of this ordinance.

SECTION 5. This ordinance shall be effective as of the date of its passage and approval.
