The ordinance passed by the City Council of the City of Chicago for **FIRESIDE TAVERN AND GRILL** on **03/16/2016**, and printed upon page **20346** of the Journal of Proceedings of the City of Chicago is here by Amended by deleting the words "area #1 shall be forty-four point six seven (44.67) feet in length and ten point eight three (10.83) feet in width for a total of four hundred eighty-three point seven eight (483.78) square feet." and inserting in their place the words "area #1 shall be twenty-six (26) feet in length and twelve point two five (12.25) feet in width and area #2 shall be twenty-two (22) feet in length and twelve point two five (12.25) feet in width for a total of five hundred nineteen and eight four (519.84) square feet."
