ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17, of the Municipal Code of Chicago, the Chicago Zoning Ordinance be amended by changing all the B3-2 Community Shopping District symbols and indications as shown on Map No. 9-G in the area bounded by

a line 337 feet northwest of the intersection of North Clark Street and North Sheffield Avenue as measured along the easterly rightof-way line of North Clark and perpendicular thereto; the alley next northeast of North Clark Street; the south right-of-way of the alley next north of and parallel to West Newport Avenue; a line from a point 76.1 feet west of North Sheffield Avenue and the south right-of-way line of the alley next north of and parallel to West Newport Avenue; to a point, 277.65 feet northwest of the intersection of North Clark Street and North Sheffield Avenue and 71.1 feet northeast of North Clark Street; a line from the previously identified point; to a point 237 feet northwest of the intersection of North Clark Street and North Sheffield Avenue and 62.93 feet northeast and perpendicular to North Clark Street both measured along North Clark Street: a line 237 feet northwest of the intersection of North Sheffield Avenue and North Clark Street as measured at the easterly right-of-way of North Clark Street and perpendicular thereto; and North Clark Street,

to those of a B3-5 Community Shopping District and a corresponding use district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.


TYPICAL FLOOR PLAN







