ORDINANCE


BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the RS3 Residential Single–Unit (Detached House) District symbols as shown on Map No. 12-H in the area bounded by:

A line 312 feet North of and parallel to West 49th Street; South Hermitage Avenue; a line 288 feet North of and parallel to West 49th Street; the public alley next West of and parallel to South Hermitage Avenue.

To those of an RM4.5, Residential Multi-Unit District

SECTION 2. This Ordinance takes effect after its passage and due publication.
