ORDINANCE

INTRO DATE: JULY 20,2016

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B3-2 Community Shopping District symbols and indications as shown on Map No 9-H in the area bounded by:

West Cornelia Avenue; North Lincoln Avenue; a perpendicular line to North Lincoln Avenue 112.50 feet long starting at a point 48 feet southeast of the south line of West Cornelia Avenue (as measured along the southwest line of North Lincoln Avenue) and ending at a point 93.71 feet south of the south line of West Cornelia Avenue (as measured along the east line of the public alley next west of North Lincoln Avenue)

To those of a B3-3 Community Shopping District and an accompanying use district is hereby established in the area described above.


SECTION 2. This ordinance takes effect after its passage and due publication.

PROJECT NARRATIVE 3462 North Lincoln Avenue

The Applicant requests a zoning change for the property located at 3462 North Lincoln Avenue from the B3-2 Community Shopping District to the B3-3 Community Shopping District in order to construct a 4-story, 50 foot tall transit-oriented, mixed-use development. The proposed building will have twenty-one (21) dwelling units and approximately 2,812 square feet of retail/commercial space and eight (8) parking spaces located on the ground floor. The proposed building is located on a pedestrian street and is approximately 600 feet from the Chicago Transit Authority Paulina Brown Line train station.


