### ORDINANCE

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

**SECTION 1.** Section 9-68-020 of the Municipal Code of Chicago is hereby amended by deleting the language stricken through and by inserting the language underscored, as follows:

#### 9-68-020 Residential parking permits.

(Omitted text is unaffected by this ordinance)

- (e) (1) If a residential parking zone is in effect at the place of residence of a person with a disability who is an owner of a vehicle licensed to a handicapped individual, as the term handicapped individual is defined in Section 3-56-050(a) of this Code, such person shall be exempt from the residential permit parking fees set forth in paragraph subsection (d) of this section.
- (2) If a residential parking zone is in effect at the place of residence of a person with a disability who holds a valid, current permit under Section 9-64-050 for a restricted parking space in such residential parking zone, such person shall be exempt from the residential parking permit fee set forth in subsection (d)(1) or (d)(2) of this section.

SECTION 2. This ordinance shall take full force and effect upon its passage and

publication.
