Being directly adjacent to subject property, we are in receipt of your intent to file an application, date indicated around September 09, 2015; for a change in zoning on behalf of your client. The basic information provided in the notice does not appear beyond what the owners have previously discussed, other than a difference in proposed zoning type.

Based on initial information it shows no reason to not grant zoning modification for stated construction. However, since no written documentation or plans have been provided to date; we reserve our rights for comment on the proposed construction prior to zoning change approval. Respectfully the following is requested for review and clarification.

- Excavation and structural vibration mitigation program to avoid damage to adjacent (1615 West Bryn Mawr) masonry structure.
- Confirmation of Builders Risk Insurance including listing 1615 West Bryn Mawr property and said property owners as additional insured.
- Confirmation that existing service facility and new service facility spaces, storage areas and site structures conform with applicable NFPA and City of Chicago Building Codes for Class 1 facilities.
- Confirmation that zoning change is temporary and will revert to previous zoning type.

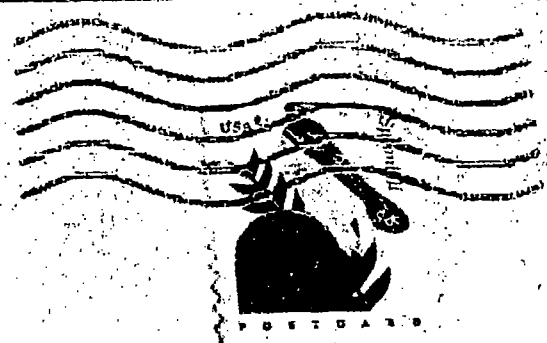

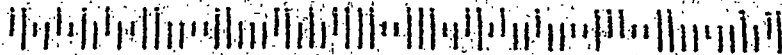

In accordance with the Amendment to the Chicago Zoning Code enacted by the City Council, Section 17-13-0107-A, please be informed that on or about September 9, 2015, I, the undersigned, intend to file an application for a change in zoning from the RS3 Residential Single Unit (Detached House) District to the C1-1 Neighborhood Commercial District, on behalf of the Applicant/Property Owner, AB Marathon Ltd., for the property located at 5550 N. Ashland, Chicago, Illinois.

The Applicant is seeking a zoning amendment in order to permit a one-story addition to the existing motor vehicle repair building located at the subject property. The proposed building addition will contain 220 sq. ft. of total building area. The building addition will contain a third automobile repair bay on site. The proposed addition will be approximately 17 ft. in height and match the existing building's height. The ten (10) onsite parking spaces will remain without change. The gasoline pumping island and canopy will remain without change.

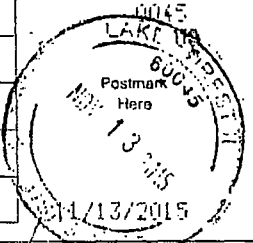

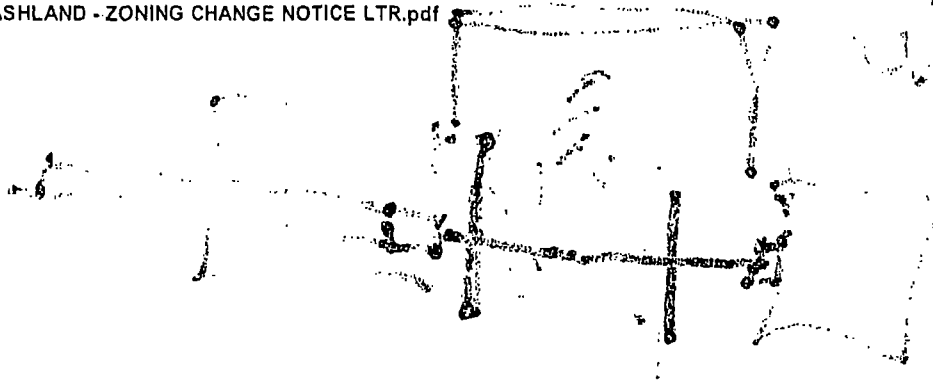
