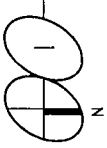

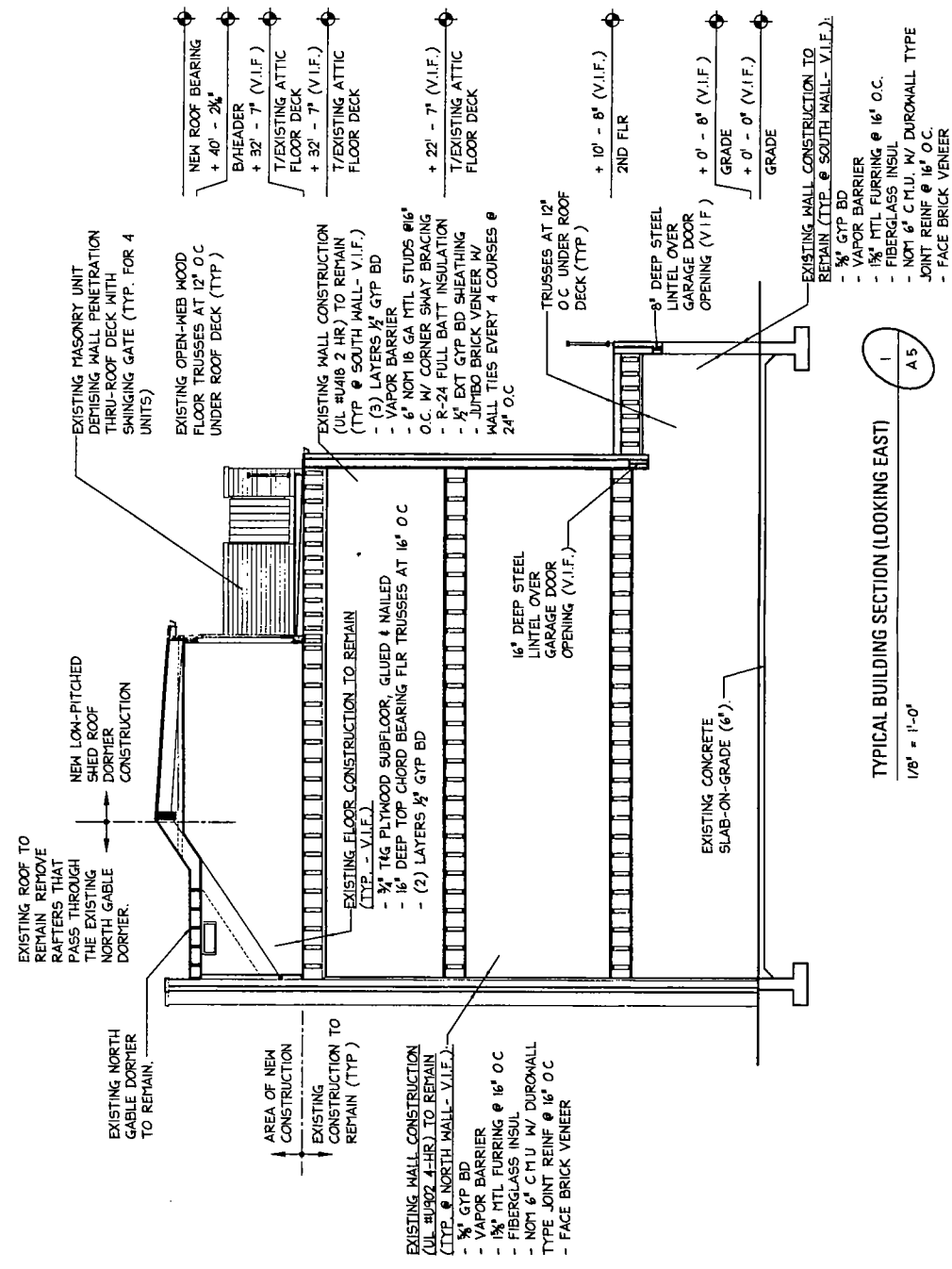

TYPICAL BUILDING SECTION (LOOKING EAST)

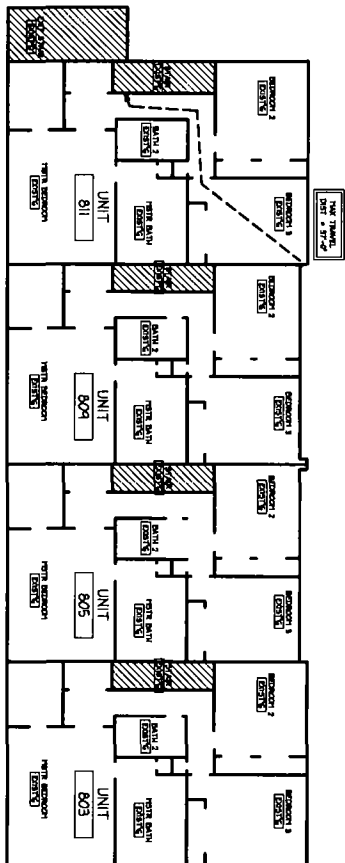

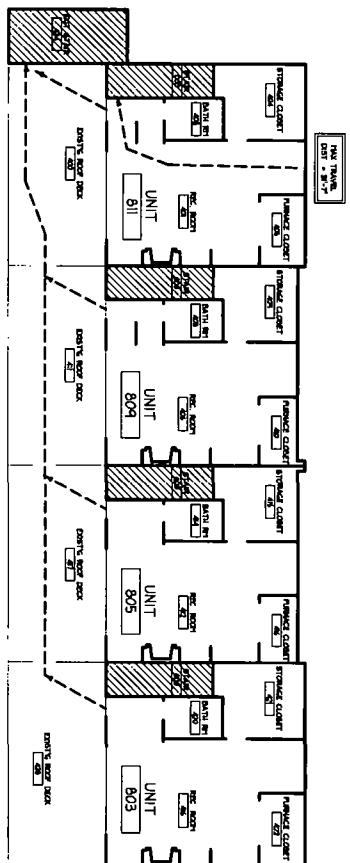
FIRST FLOOR EXIT DIAGRAM (EXISTING)

FOURTH FLOOR EXIT DIAGRAM (NEW)

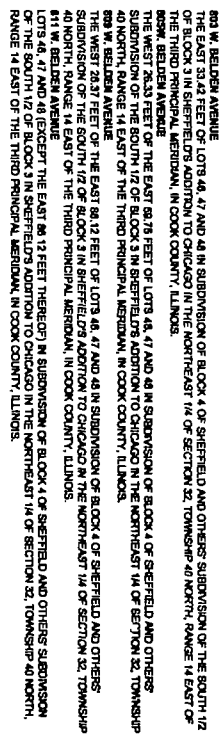
