#### ORDINANCE

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

**SECTION 1.** That the Chicago Zoning Ordinance be amended by changing all of the DX-7 Downtown Mixed-Use District symbols and indications as shown on Map 1-F in the area bounded by:

North LaSalle Street; West Huron Street; the public alley next west of and parallel to North LaSalle Street and the public alley next south of and parallel to West Huron Street;

to those of DX-7 Downtown Mixed-Use District in accordance with the attached narrative and plans.

**SECTION 2.** This Ordinance shall be in force and effect from and after its passage and publication.


LaSalle 676 LLC is the "Applicant" for a Type 1 Zoning Map Amendment for the subject property located at 670-678 North LaSalle from the DX-7 Downtown Mixed-Use District to the DX-7 Downtown Mixed-Use District as a Type 1 zoning map amendment.


The site is bounded by North LaSalle Street to the east, West Huron Street to the north, a 14 foot public alley. to the west and an 18 foot public alley to the south. The property is surrounded by properties zoned DX-7 on the east and west, PD 1251 to the south and property zoned DX-5 to the north.


The subject property consists of approximately 18,381 square feet and is currently occupied by an existing 6story commercial building and a surface parking lot. The Applicant proposes to add a 2-story addition to the existing 6-story building and erect a new 8-story building addition to the east of and connected to the existing building with a rooftop patio. The development will contain 149 dwelling units with ground floor retail/commercial space. A total of 20 off-street parking spaces will be provided. 17 parking spaces will be located in the basement and an additional 3 parking spaces will be provided at ground level.



As required by Section 17-13-0107 of the Municipal Code of the City of Chicago, please be informed that on or about September 8, 2016, the undersigned, on behalf of LaSalle 676 LLC (the "Applicant"), intends to file an application to rezone the property located at 670-678 North LaSalle, Chicago, Illinois, from the DX-7 Downtown Mixed-Use District to the DX-7 Downtown Mixed-Use District as a Type 1 Zoning Map Amendment. A map of the development site is printed on the reverse side of this letter.

The development site is currently occupied by an existing 6-story mixed-use building and a surface parking lot. The application requests a rezoning of the subject property from the DX-7 Downtown Mixed-Use District to the DX-7 Downtown Mixed-Use District as a Type 1 Zoning Map Amendment to allow the reuse and expansion of the existing 6-story building with a 2-story addition and an 8-story building addition on the existing parking lot to the east. The proposed development will provide ground floor commercial space, a total of 149 dwelling units and 20 off-street parking spaces. The Type 1 Zoning Map Amendment is necessary to allow a reduction in required parking by over 50% for a residential use pursuant to the transit-served location provisions of the Zoning Ordinance.

The proposed change of zoning does *not* apply to your property. You are receiving this notice as required by the Chicago Municipal Code because the assessor's tax records indicate that you own property within 250 feet of the proposed Planned Development.


