### **ORDINANCE**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning

Ordinance is hereby amended by changing all of the RM5 Residential Multi-Unit

District and the M1-2 Limited Manufacturing/Business Park District symbols as shown

on Map No. 8-I

in the area bounded by:

A line 369.92 feet North of and parallel to West 36th Street; a line 229 feet East of and

parallel to South Maplewood Avenue; a line 253.53 feet North of and parallel to West

36th Street; a line 132 feet East of and parallel to South Maplewood Avenue; a line

146.30 feet North of and parallel to West 36th Street; South Maplewood Avenue.

To those of an RM5 Residential Multi-Unit District

SECTION 2. This Ordinance takes effect after its passage and due publication.




