ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the RS3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No. 5-I in the area bounded by

the alley next northeast of and parallel to North Stave Street; a line 48 feet southeast of and parallel to West Prindiville Street; North Stave Street; and West Prindiville Street,

to those of a B2-3 Neighborhood Mixed-Use District and a corresponding uses district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.








 \mathbb{Z} 1 TYP. 1ST FL. PLAN - TOWNHOMES #2-6 SPACE SHEET





Z 1 TYP. 2ND FL. PLAN - TOWNHOMES #2-6


