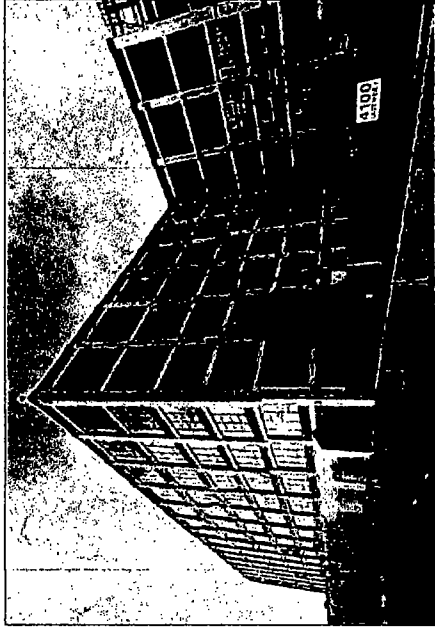
- 3/8" lag bolts & shields or thru bolts with aluminum mtg. clip.

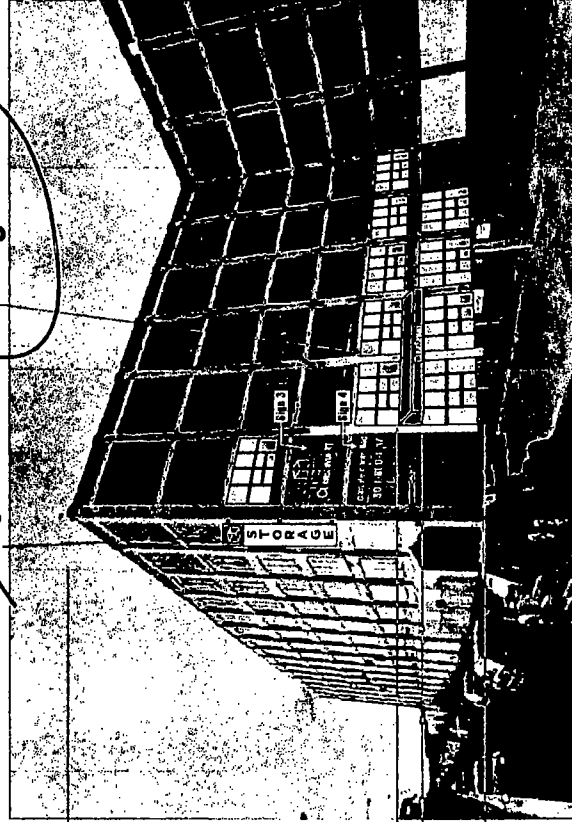
