ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No. 9-K in the area bounded by

West School Street; the public alley next west of and parallel to North Kildare Avenue; the public alley next south of and parallel to West School Street; a line 50 feet west of and parallel to the public alley next west of and parallel to North Kildare Avenue,

to those of an RT4 Residential Two-Flat, Townhouse and Multi-Unit District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.




PLAT OF SURVEY OF
