SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the C1-2 and C2-1 Motor Vehicle-Related Commercial District symbols and indications as shown on Map No. 3-I in an area bound by

The alley next West and parallel to North Western, a line 144.0 feet North of and parallel West Lemoyne Street, North Western Avenue, a line 96.0 feet North of and parallel to West Lemoyne Street

to those of a B2-3 Neighborhood-Mixed Use District.






