# 19045 INTRO. DATE. DEC. 14, 2016

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B1-2 Neighborhood Shopping District symbols and indications as shown on Map No. 9-H in an area bound by

A line 48 feet West of and parallel to North Seeley Avenue, the alley next North of and parallel to West Roscoe Street, a line 24 feet West of and parallel to North Seeley Avenue, West Roscoe Street.

to those of a B3-2 Community Shopping District.

SECTION 2. This ordinance takes effect after its passage and due publication.




