BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the M2-3 Light Industry District symbols and indications as shown on Map No. 7-I in the area bounded by:

A line 664.11 feet north of and parallel to West Wellington Avenue; the west boundary line of the North Branch of the Chicago River; a line 350.43 feet north of and parallel to West Wellington Avenue; a line 150 feet east of and parallel to North Rockwell Street; a line 507.61 feet north of and parallel to West Wellington Avenue; and North Rockwell Street;



In accordance with the Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about **December 6, 2016**, I, the undersigned, will file an application for a change in zoning from a M2-3 Light Industry Manufacturing District to a C3-3 Commercial, Manufacturing and Employment District on behalf of Rockwell Properties LLC.

The applicant seeks a zoning amendment to a C3-3 Commercial, Manufacturing and Employment District in order to allow the following businesses at addresses 3053 N. Rockwell:

The applicant intends to use **3053 N. Rockwell** for several food and beverage light manufacturing uses: there are currently 13 buildings that are undergoing permitting and construction for 6 proposed businesses that will utilize the new converted space. Building "1" is 1-story and has over/approx. 17,000 square feet for a coffee roaster and 2

Building "1" is 1-story and has over/approx. 17,000 square feet for a coffee roaster and 2 loading docks at east rear of property.

Building "2" has over/approx. 16,000 square feet for a proposed industrial space.

Building "3" is 2-story has over/approx 11,000 square feet on the main floor for artisanal food and a second floor for office space.

Buildings "4, 5, and 6" are 2-stories with a portion for mezzanine and offices above, the first floor has a proposed use for a brewery and tasting room that will use over 20,000 square feet.

Building "10" is 2-stories and has over 4300 square feet to allow a proposed distillery.

Building "11" has 3 stories, over 4300 square feet and a proposed use as a restaurant.

There is an existing 2-story bridge between building "10" and building "3". Buildings 7, 8 and 9 were demolished.

There is an existing driveway to allow outdoor parking within the parcel for 40 parking spaces, including 4 handicapped spaces.

There are no dwelling units.

There are no changes to building height.

The buildings together are connected on 3 parcels that are 126,014 square feet.
