RESERVED PARKING (2% DISABLED)

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. That the Commissioner of Transportation is hereby authorized and directed to install and/or amend Reserved Parking (2% Disabled) Signs at the below listed locations:

11	South Jefferson Street; South Jefferson Street (west side) from a point 390 feet south of West Maxwell Street to a point 100 feet thereof; Reserved Parking (2% Disabled), Public Benefit, All Times, All Days [O2017-7]
32	2869 North Lincoln Avenue; West George Street (south side) from a point 83 feet east of North Lincoln Avenue to a point 20 feet east thereof; Reserved Parking (2% Disabled), 9:00am to 6:00pm, Monday through Friday, 9:00am to 1:00pm, Saturday -- (16-0804166) [O2016-7746]
47	4735 North Lincoln Avenue; Repeal Ordinance Passed 07/10/2002, journal page 90171, which reads: North Lincoln Avenue (east side) from a point 300 feet south of East St. Lawrence Avenue to a point 335 feet south thereof; No Parking Loading Zone, 5:00pm to 2:00am, Thursday through Sunday, by Striking the above; Also Add, Repeal Ordinance which passed 01/12/1995, journal page 64648, which reads: North Lincoln Avenue (east side) from a point 320 south of West Lawrence Avenue to a point 10 feet south thereof; Reserved Parking (2% Disabled), by Striking the above; Also Add, North Lincoln Avenue (east side) from a point 31 feet south of West Giddings Street to a point 10 feet south thereof; Reserved Parking (2% Disabled), All Times, All Days, And Also Add North Lincoln Avenue (east side) from a point 41 feet south of West Giddings Street to a point 10 feet south thereof; No Parking Loading Zone, 5:00pm to 2:00am, Thursday through Sunday -- (16-05531167) [O2016-5967]
