SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the RS3 Residential Single-Unit (Detached House) District Symbols and indications as shown on Map No. 3-K in the area bounded by

a line 185.5 feet west of and parallel to North Keeler Avenue; West Potomac Avenue, a line 216.5 feet west of and parallel to North Keeler Avenue; and the alley immediately north of and parallel to West Potomac Avenue;






