BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:


SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the RS-3 Single-Unit (Detached House) District symbols and indications as shown on Map No. 6-I in the area bounded by:

West 24th Street; South Western Avenue; a line 144.00 feet south of West 24th Street; and the public alley next west of South Western Avenue

to those of a B3-1 Community Shopping District.

SECTION 2. This Ordinance shall be in force and effect from and after its passage and due publication.

Please take notice that under the Chicago Zoning Ordinance an application (the "Application") to change the RS-3 Single-Unit (Detached House) District classification to those of an B3-1 Community Shopping District for the area which is bounded by:

West 24th Street; South Western Avenue; a line 144.00 feet south of West 24th Street; and the public alley next west of South Western Avenue
