BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:


SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the RS-3 Single-Unit (Detached House) District symbols and indications as shown on Map No. 11-H in the area bounded by:

West Leland Avenue; North Damen Avenue; a line 50.0 feet south of West Leland Avenue; and the public allcy next west of North Damen Avenue

to those of a B2-1 Neighborhood Mixed-Use District.

SECTION 2. This Ordinance shall be in force and effect from and after its passage and due publication.

Please take notice that under the Chicago Zoning Ordinance an application (the "Application") to change the RS-3 Single-Unit (Detached House) District classification to those of an B2-1 Neighborhood Mixed-Use District for the area which is bounded by:

West Leland Avenue; North Damen Avenue; a line 50.0 feet south of West Leland Avenue; and the public alley next west of North Damen Avenue
