#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby

amended by changing all of the RS-3 Residential Single-Unit (Detached House) District symbols and

indications as shown on Map No. 15-I in the area bounded by



In accordance with the Amendment to the Zoning Code enacted by the City Council, Section 17-13-0107-A of the Chicago Zoning Ordinance, please be advised that on or about March 22, 2017, the undersigned, will file an application for a change in zoning for the property located 6048 North Fairfield Avenue from a RS-3 Residential-Single Unit (Detached House) District to a RT-4 Residential Two-Flat, Townhouse and Multi-Unit District.

The owner of the property and the applicant of the zoning amendment is JVA IL, LLC located at 626 W Randolph, Suite 1, Chicago, IL 60661.

The applicant is requesting a zoning amendment from a RS-3 Residential-Single Unit (Detached House) District to a RT-4 Residential Two-Flat, Townhouse and Multi-Unit District to allow for a fourth dwelling unit to be located on the ground floor and a fourth parking space to an existing three story building containing three dwelling units and three parking spaces. 
