MAY STREET, LLC

Be It Ordained by the City Council of the City of Chicago:

SECTION 1. Permission and authority are hereby given and granted to MAY STREET, LLC, upon the terms and subject to the conditions of this ordinance to construct, install, maintain and use three (3) Foundation Support(s) (Footing) under the public right-of-way adjacent to its premises known as 216 N. May St..

Said Foundation Support(s) (Footing) at Public Alley measure(s):

One (1) at forty-two point eight three (42.83) feet in length, and point six seven (.67) feet in width for a total of twenty-eight point seven (28.7) square feet. Said footing shall be approximately five (5) feet below grade level.

Said Foundation Support(s) at N. May Street measure(s):

One (1) at twenty-three point zero eight (23.08) feet in length, and point six seven (.67) feet in width for a total of fifteen point four six (15.46) square feet. Said footing shall be approximately three (3) feet six (6) inches below grade level.

One (1) at eleven point zero eight (11.08) feet in length, and point zero eight (.08) feet in width for a total of point eight nine (.89) square feet. Said footing shall be approximately three (3) feet six (6) inches below grade level.

The location of said privilege shall be as shown on prints kept on file with the Department of Business Affairs and Consumer Protection and the Office of the City Clerk.

Said privilege shall be constructed in accordance with plans and specifications approved by the Department of Planning and Development and Department of Transportation (Office of Underground Coordination).

This grant of privilege in the public way shall be subject to the provisions of Section 10-28-015 and all other required provisions of the Municipal Code of Chicago.

The grantee shall pay to the City of Chicago as compensation for the privilege #1126578 herein granted the sum of four hundred (\$400.00) per annum in advance.

A 25% penalty will be added for payments received after due date.

The permit holder agrees to hold the City of Chicago harmless for any damage, relocation or replacement costs associated with damage, relocation or removal of private property caused by the City performing work in the public way.


