**ORDINANCE**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. That the Chicago Zoning Ordinance be amended by changing all the B3-2 Commercial Shopping District symbols and indications as shown on Map No. 11-H in the area bounded by:

West Lawrence Avenue; a line 150 feet east of North Oakley Avenue; the public alley next south of West Lawrence Avenue; and a line 90.16 feet east of North Oakley Avenue

to those of a B2-3 Neighborhood Mixed-Use District which is hereby established in the area described above.

SECTION 2. This Ordinance shall be in force and effect from and after its passage and due publication.

2245-49 W. Lawrence Avenue

The subject property contains 7,345 square feet of land, and is currently a vacant commercial building. The Applicant proposes to rezone the property to B2-3 to allow the construction of a new four-story building consisting of 24 residential dwelling units, approximately 2,244 square feet of basement level commercial space, six automobile parking spaces\*, 20 bicycle parking spaces and no loading berth. The height of the building will be 48 feet 2 inches.










