**ORDINANCE**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

A line twenty five feet West of and parallel to south Wallace Street, the alley next North of and parallel to West 26<sup>th</sup> Street, South Wallace Street, West 26<sup>th</sup> Street.
