ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RS-3 Residential Single Unit (Detached Home) District symbols and indications as shown on Map No. 8-H in an area bound by

A line 24 feet West of and parallel to South Hermitage Avenue, the alley next North and parallel to West 35th Street, South Hermitage Avenue and West 35th Street

to those of a B2-3 Neighborhood Mixed Use District.

SECTION 2. This ordinance takes effect after its passage and due publication.




Zoning from RS-3 to B2-3
