#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the RS3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No. 7-J in the area bounded by:

West Wrightwood Avenue; North St. Louis Avenue; the public alley next south of West Wrightwood Avenue; and a line 37.3 feet west of North St. Louis Avenue





Please take notice that under the Chicago Zoning Ordinance an application (the "Application") to change the RS3 Residential Single-Unit (Detached House) District classification to those of an RM4.5 Residential Multi-Unit District for the area which is bounded by:


West Wrightwood Avenue; North St. Louis Avenue; the public alley next south of West Wrightwood Avenue; and a line 37.3 feet west of North St. Louis Avenue
