BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:


SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all the B1-1 Neighborhood Shopping District symbols and indications as shown on Map No. 16-J in the area bounded by

West Devon Avenue; the alley next east of and parallel to North Pulaski Road: the alley next south of and parallel to West Devon Avenue; and a line 167 feet east of and parallel to North Pulaski Road,

to those of a B1-2 Neighborhood Shopping District is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.


