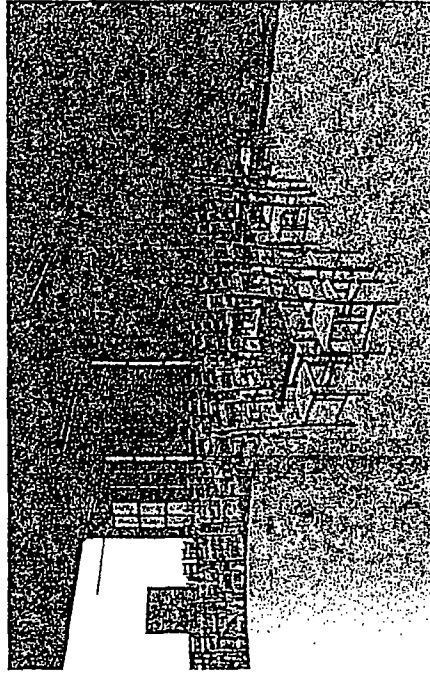
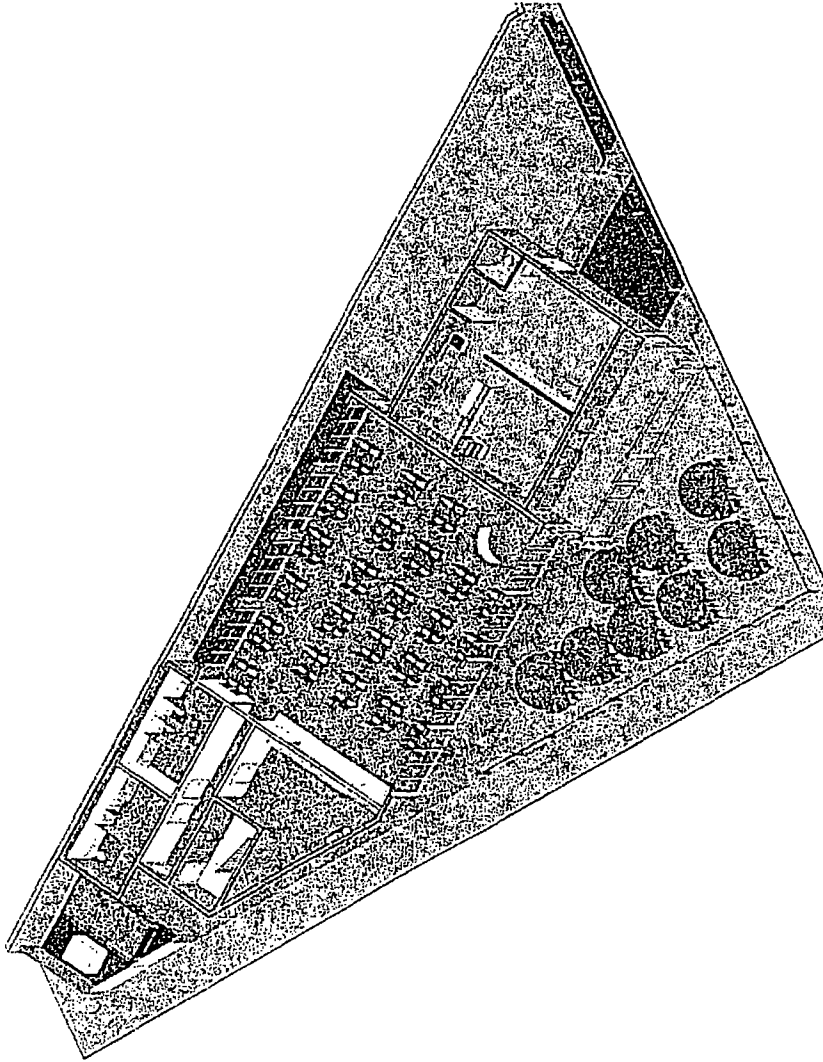

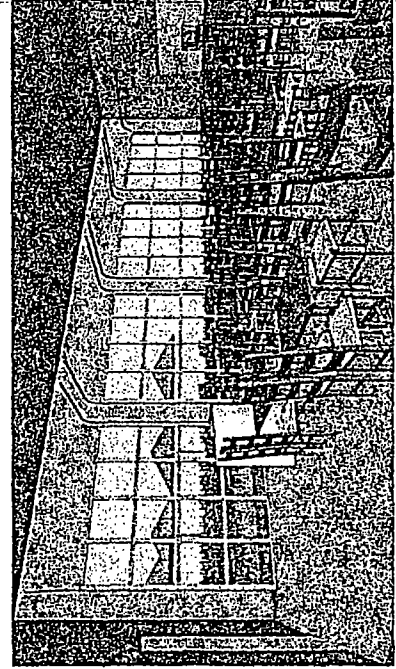
to those of a C3-3 Commercial, Manufacturing and Employment District.

Layout (Level-1)

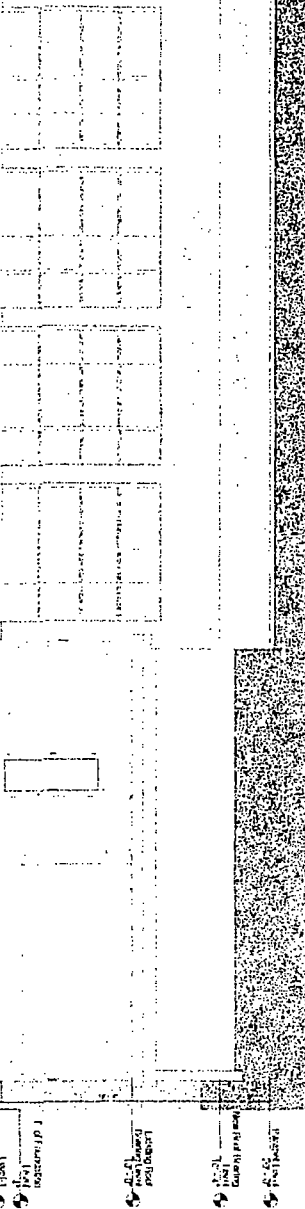
