***BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:***

***SECTION 1.*** Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B3-1 Community Shopping District symbols and indications as shown on Map No. 24-A in the area bounded by

A line 135.60 feet south of the south line of East 99<sup>th</sup> Street; South Ewing Avenue; a line 185.60 feet south of the south line of East 99<sup>th</sup> Street; a line commencing at a point 77.88 feet west of the west line of South Ewing Avenue and 185.60 feet south of the south line of East 99<sup>th</sup> Street traveling northwesterly to a point 121.50 feet west of the west line of South Ewing Avenue and 142.85 feet south of the south line of East 99<sup>th</sup> Street; a line 121.50 feet west of the west line of South Ewing Avenue

to those of a C2-1 Motor Vehicle-Related Commercial District.

***SECTION 2.*** This ordinance shall be in force and effect from and after its passage and due publication.

In accordance with the requirements for an amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about May 17, 2017, the undersigned intends to file an application for a change in zoning for the property with an address range of 9912 to 9914 South Ewing Avenue (the "Property") from B3-1 Community Shopping District to C2-1 Motor Vehicle-Related Commercial District.

The property is currently improved with a two and a half-story, frame building with a basement consisting entirely of residential space with two dwelling units on the first and second floors totaling four dwelling units. 
