BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B3-1 Community Shopping District symbols and indications as shown on Map No. 24-A in the area bounded by

A line 135.60 feet south of the south line of East 99th Street; South Ewing Avenue; a line 185.60 feet south of the south line of East 99th Street; a line commencing at a point 77.88 feet west of the west line of South Ewing Avenue and 185.60 feet south of the south line of East 99th Street traveling northwesterly to a point 121.50 feet west of the west line of South Ewing Avenue and 142.85 feet south of the south line of East 99th Street; a line 121.50 feet west of the west line of South Ewing Avenue and 142.85 feet south of the south line of East 99th Street; a line 121.50 feet west of the west line of South Ewing Avenue and 142.85 feet south of the south line of East 99th Street; a line 121.50 feet west of the west line of South Ewing Avenue

to those of a C2-1 Motor Vehicle-Related Commercial District.



In accordance with the requirements for an amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed that on or about May 17, 2017, the undersigned intends to file an application for a change in zoning for the property with an address range of 9912 to 9914 South Ewing Avenue (the "Property") from B3-1 Community Shopping District to C2-1 Motor Vehicle-Related Commercial District.

The property is currently improved with a two and a half-story, frame building with a basement consisting entirely of residential space with two dwelling units on the first and second floors totaling four dwelling units. The applicant is seeking to rezone to use part of the property for a used car dealership. The applicant proposes to convert the first floor front residential unit to commercial space. The other three dwelling units will remain. The applicant proposes to improve the gravel lot for open parking.
