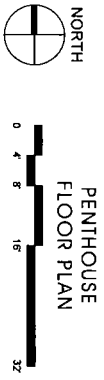
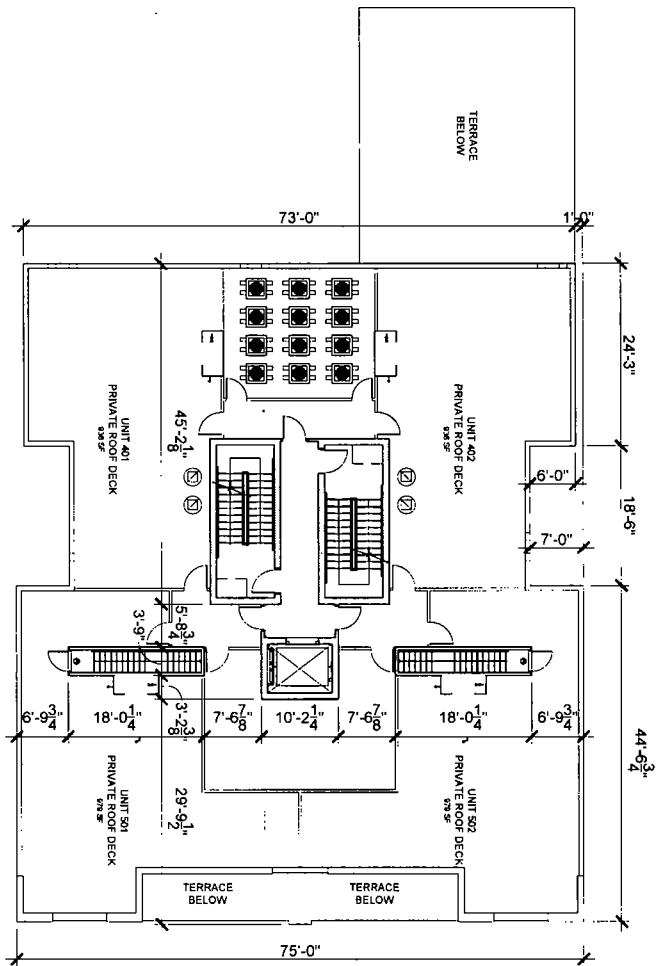




TYPICAL (2-4)

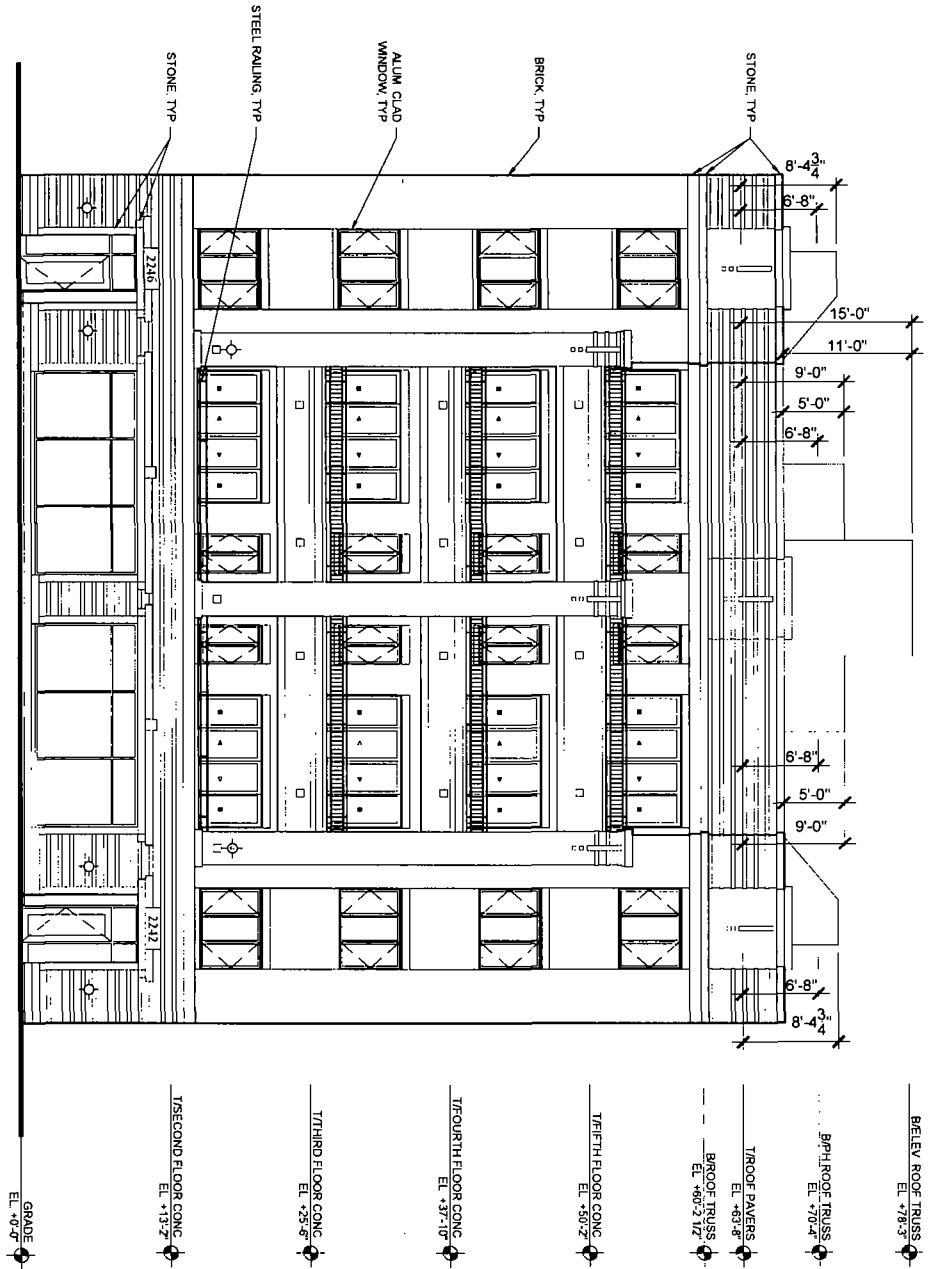

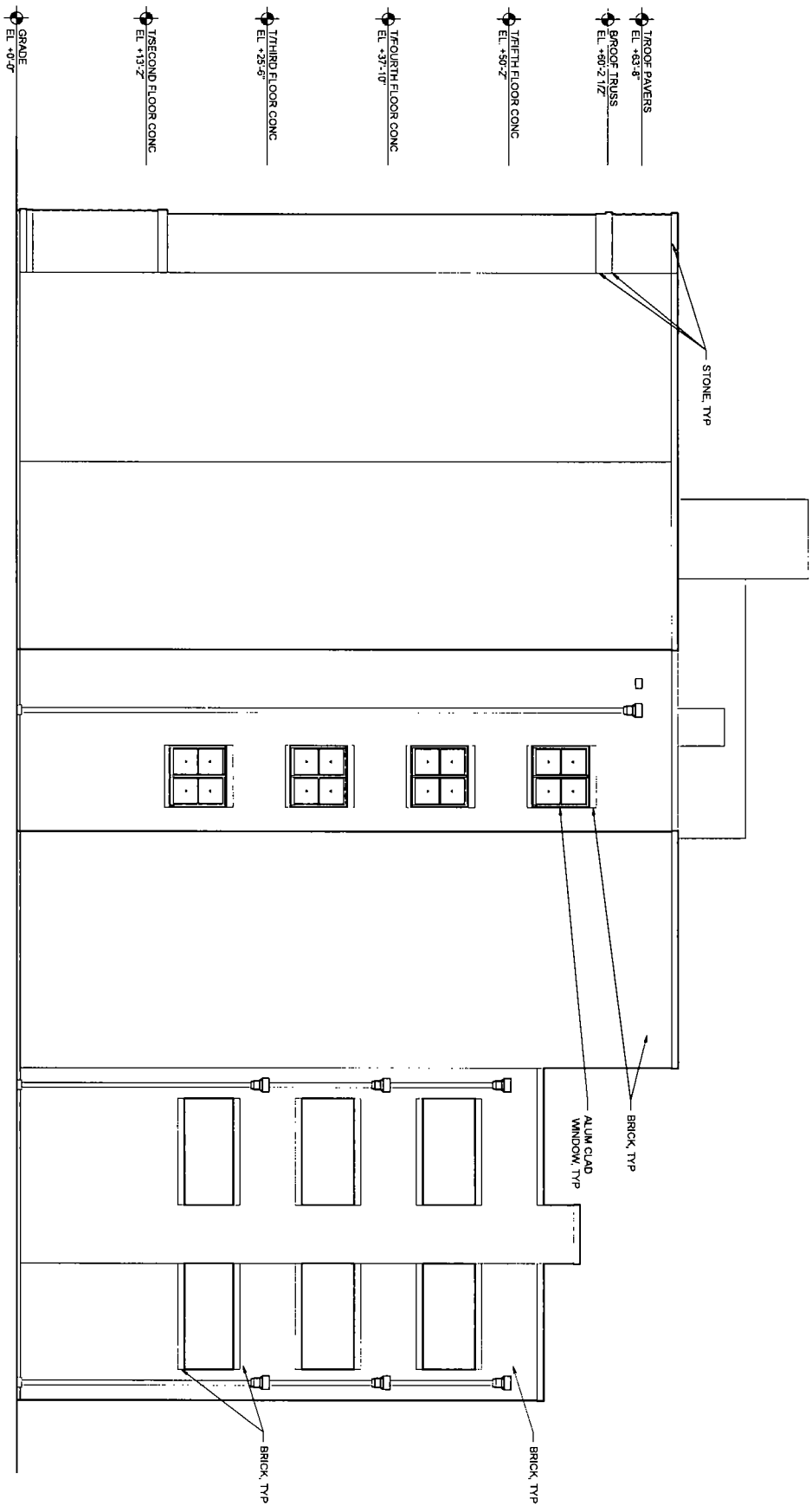
**PENTHOUSE
