ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the RT4, Residential Two-Flat, Townhouse and Multi-Unit District symbols as shown on Map No. 5-1 in the area bounded by:

The public alley next North of and parallel to West Lyndale Street; a line 353.20 feet East of and parallel to South Sacramento Avenue; West Lyndale Street; a line 328.20 feet East of and parallel to South Sacramento Avenue.

To those of a B2-3 Neighborhood Mixed-Use District

SECTION 2. This Ordinance takes effect after its passage and due publication.

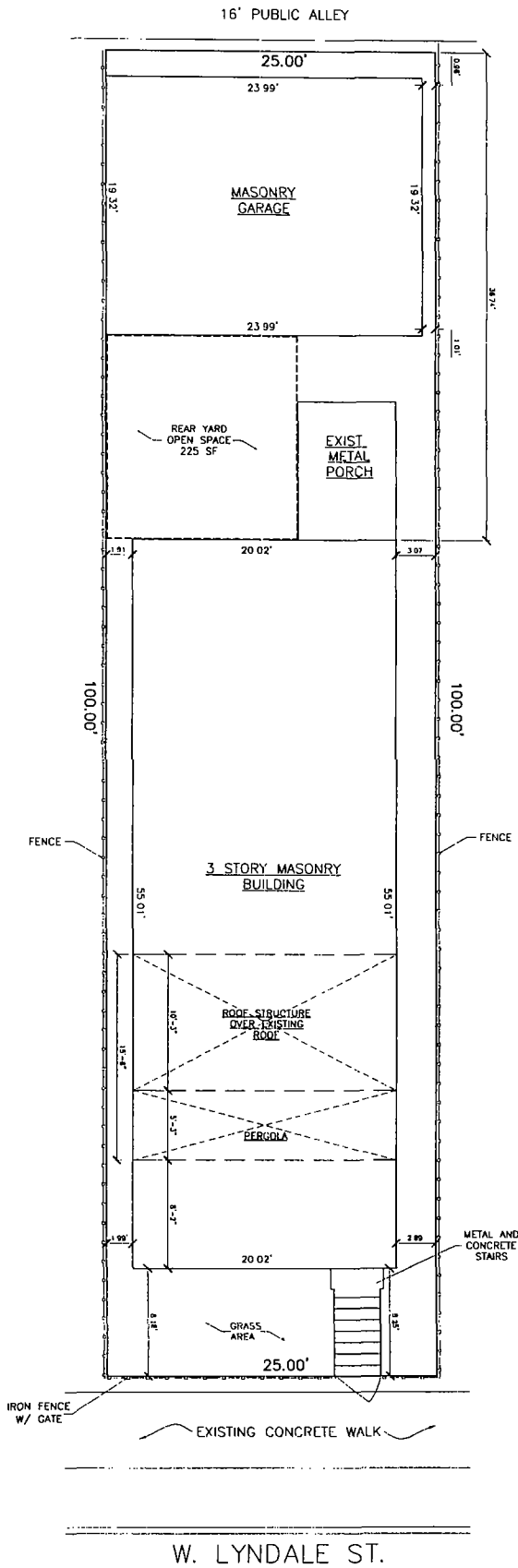
