a line 48.00 feet South of and parallel to West Concord Place; North Damen Avenue; the alley next North of and parallel to North Milwaukee Avenue; the alley next West of and parallel to North Damen Avenue,

to the designation of the B3-3 Community Shopping District, which is hereby established in the area above described.


