## ORDINANC E

## BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

**SECTION 1.** Title 17, of the Municipal Code of Chicago, the Chicago Zoning Ordinance be amended by changing all the Institutional Planned Development No. 60, *As Amended*, symbols and indications as shown on Map No. 11-H in the area bounded by

West Wilson Avenue; the alley next west of and parallel to North Wolcott Avenue; West Sunnyside Avenue and North Damen Avenue,

to those of a B2-2 Neighborhood Mixed-Use District and a corresponding use district is hereby established in the area above described.

SECTION 2. Title 17, of the Municipal Code, the Chicago Zoning Ordinance, be amended by changing all the B2-2 Neighborhood Mixed-Use District symbols and indications within the area hereinabove described to the designation of Institutional Residential-Business Planned Development Number No. 60, As Amended, which is hereby established in the area above described, subject to such use and bulk regulations as are set forth in the Plan of Development attached and made a part thereto and to no others.

**SECTION** 3. This ordinance shall be in force and effect from and after its passage and due publication.

## INSTITUTIONAL RESIDENTIAL-BUSINESS PLANNED DEVELOPMENT NO. 60, AS AMENDED

## PLAN OF DEVELOPMENT STATEMENTS

- 1. The area delineated herein as Institutional Residential-Business Planned Development No. 60, as Amended ("Planned Development"), consists of approximately three hundred and ten thousand, two hundred and sixty (310,260) square feet or seven point twelve (7.12) acres of real property \*("Subject Property"), as shown, which is depicted on the attached Planned Development Boundary and Property Line Map (PD Exhibit \_\_\_\_\_). The Applicant, Ravenswood Senior Living LP, an Illinois Limited Partnership, has filed this application with the authorization of the Owners of the Subject Property.
- 2. The requirements, obligations and conditions contained within this Planned Development shall be binding upon the Applicant, its successors and assigns and, if different than the Applicant shall inure to the benefit of the Applicant's successors and assigns and, if different than the Applicant, the legal title holder and any ground lessors. Furthermore, pursuant to the requirements of Section 17-8-0400 of the Chicago Zoning Ordinance, the Subject Property, at the time of application for amendments, modifications or changes (administrative, legislative, or otherwise) to this Planned Development are made, shall be under single ownership or designated control. [Single designated control is defined in Section 17-8-0400 of the Chicago Zoning Ordinance.]
- 3. All applicable official reviews, approvals and/or permits are required to be obtained by the Applicant or its successors, assignees or grantees as to Subarea C. The owners (or their respective successors, assignees or grantees), of Subareas A, B, D and E, are required to obtain all applicable official reviews, approvals or permits as it relates to each owner's respective subarea. Any dedication or vacation of streets, alleys or easements or any adjustments to any right-of-way (ROW) shall require a separate submittal to the Chicago Department of Transportation (CDOT), on behalf of the Applicant or its successors, assigns or grantees.

Any requests for grants of privilege, or any items encroaching on the public way, shall be in compliance with this Planned Development.

Ingress or egress shall be pursuant to the Planned Development and may be subject to the review and approval of the Department of Planning and Development (DPD) and/or the Chicago Department of Transportation (CDOT). Closure of all or any public street or alley, during demolition or construction, shall be subject to the review and approval of the Chicago Department of Transportation (CDOT).

All work proposed in the public way must be designed and constructed in accordance with the Chicago Department of Transportation's Construction Standards, for work in the public way, and shall be in compliance with Municipal Code of Chicago - accordingly.

Prior to the issuance of any "Part II" approval, the submitted plans - for the Planned Development, must be approved by the Chicago Department of Transportation (CDOT).

- This Plan of Development consists of sixteen (16) Statements: a Bulk Regulations and Data Table; an Existing Zoning Map; an Existing Land-Use Map; a Planned Development Boundary and Property Line Map; a Site Plan; a Landscape Plan; a Green Roof Plan; a Sub-Area Map; a Pedestrian/Vehicular Route Map; Floor Plans and Building Elevations, all of which were prepared by Worn Jerabek Wiltse Architects and dated February 22, 2017, and which are submitted and referenced herein accordingly. In any instance where a provision of this Planned Development conflicts with the Chicago Building Code, the Building Code shall control. This Planned Development conforms to the intent and purpose of the Zoning Ordinance, and all requirements thereto, and satisfies the established criteria for approval as a Planned Development. In case of a conflict between the tenets of this Planned Development Ordinance and the Zoning Ordinance, this Planned Development Ordinance shall control.
- 5. The following uses are allowed in the area delineated herein as Institutional Residential-Business Planned Development No. 60, as Amended, and shall include the following, without limitation:
  - Sub-Area A: Business, commercial and service uses allowed in the Commercial and Public and Civic Use Categories of the B2 District classification including without limitation office, health club, medical service, school and day care, accessory uses supporting the same, and accessory off-street parking and loading;
  - Sub-Area B: School (with accessory uses); small entertainment and spectator sports venues (including without limitation sports field and gymnasium, with spectator seating relating to a school); temporary housing for students, faculty and visiting faculty; and accessory uses supporting the same and accessory off-street parking and loading;
  - Sub-Area C: Residential-elderly housing (independent seniors and supportive living facility); medical office; related and accessory uses supporting the same; and accessory off-street parking and loading;

- Sub-Area D: Multi-unit residential; related and accessory uses supporting the same; and accessory off-street parking and loading; and
- Sub-Area E: Accessory and non-accessory off-street parking.
- 6. On-premise signs and temporary signs, such as construction and marketing signs, shall be permitted within the Planned Development, subject to the review and approval of the Department of Planning and Development (DPD). Off-premise signs are prohibited within the boundary of the Planned Development.
- 7. For purposes of height calculations and measurements, the definitions in the Zoning Ordinance shall apply. The height of any building shall also be subject to height limitations established by the Federal Aviation Administration (FAA).
- 8. The maximum permitted floor area ratio (FAR), for the Property, shall be in accordance with the attached Bulk Regulations and Data Table (Exhibit \_\_\_). For the purposes of FAR calculations and measurements, the definitions in the Zoning Ordinance shall apply. The permitted FAR, identified in the Bulk Regulations and Data Table, has been determined using a net site area of 310,260 square feet and a base FAR of 2.2.
- 9. Upon review and determination, and pursuant to section 17-13-0610 of the Zoning Ordinance, Part II Review shall be assessed a fee, by the Department of Planning and Development (DPD). The fee, as determined by Staff at the time of submission, is final and binding on the Applicant and must be paid to the Chicago Department of Revenue, prior to the issuance of any Part II Approval.
- 10. The Site and Landscape Plans shall be in substantial conformance with the Landscape Ordinance and any corresponding regulations and guidelines, including Section 17-13-0880 of the Zoning Ordinance. Final landscape plan review and approval will be by the Department of Planning and Development (DPD). Any interim reviews associated with Site plan review or Part II Reviews, are conditional until final Part II Approval.
- 11. The tenets and conditions of development, under this Planned Development Ordinance, may be modified administratively, pursuant to Section 17-13-0611-A of the Zoning Ordinance, by the Zoning Administrator, upon written application for such modification, by the Applicant, its successors and assigns and, if different than the Applicant, the legal titleholders and any ground lessors.
- 12. The Applicant acknowledges that it is in the public interest to design, construct and maintain the project in a manner which promotes, enables and maximizes universal access throughout the Subject Property. Plans for all buildings and improvements, within the


Planned Development Boundary, shall be reviewed and approved by the Mayor's Office for People with Disabilities (MOPD), to ensure compliance with all applicable laws and regulations related to access for persons with disabilities and to promote the highest standard of accessibility.

- 13. The Applicant will comply with the Rules and Regulations, for the Maintenance of Stockpiles, as promulgated by the Commissioner of Streets and Sanitation, the Commissioner of the Environment and the Commissioner of Buildings, pursuant to Section 13-32-125 of the Municipal Code of Chicago or any other relevant provision of that Code.
- 14. The Applicant acknowledges that it is in the public interest to design, construct, renovate and maintain all buildings in a manner that provides healthier indoor environments, reduces operating costs, conserves energy and maximizes the preservation of natural resources. [At the time of a hearing, before the Chicago Plan Commission, all developments must be in substantial compliance with the current City of Chicago Sustainable Development Policy, as set forth by the Department of Planning and Development.]
- 15. The Plans, submitted herewith and incorporated herein by reference, are hereby approved in their entirety, and no further approvals shall be required under this Planned Development or the Zoning Ordinance, for the improvements undertaken in accordance with said Plans, other than Part II Review and Approvals, as required under Section 17-13-010 of the Zoning Ordinance.
- 16. This Planned Development shall be governed by Section 17-13-0612, et seq.

Should this Planned Development Ordinance lapse, the Commissioner of the Department of Planning and Development (DPD) shall initiate a Zoning Map Amendment to rezone the property to Institutional Planned Development Number 60, as amended (October 5, 2011 – City Council Journal, Pages 9208-9225).

In accordance with Amendment to the Zoning Code enacted by the City Council, Section 17-13-0107-A, please be informed that on or about **May 17**, **2017**, I, the undersigned, intend to file an application for a change in zoning from the Institutional Planned Development No. 60, As Amended to a B2-2 Neighborhood Mixed-Use District and then to Institutional Residential-Business Planned Development No. 60, As Amended, on behalf of the Applicant, Ravenswood Senior Living LP, for the property located at **4501 North Winchester Avenue**, Chicago, Illinois.

The Applicant is seeking to amend the existing Planned Development in order to permit the rehabilitation, expansion and conversion of the existing eight-story, with one-story addition, medical office building (Sub-Area C) - into an Independent Senior and Supportive Living Facility. The proposed new Senior and Supportive Living Facility will contain seventy-four (74) elderly housing (dwelling) units and one hundred and twenty (120) supportive living (dwelling) units – for a total of one hundred and ninety-four (194) dwelling units. The newly converted building will also contain ancillary offices, common areas, a cafeteria (with kitchen), and other residential amenity rooms. Off-street parking for residents, employees and guests of the proposed Senior and Assisted Living Facility will be provided in the existing parking garage (Sub-Area E). Part of the renovation plan calls for the erection of a one-story vertical addition to the existing eight-story building, resulting in a total height of 139 feet-4 inches. The newly renovated building, with proposed addition, is masonry in construction. There will be no changes to any other existing buildings, structures or improvements (Sub-Areas A, B, D and E), located within the existing Planned Development.
