

a line 100.0 feet north of and parallel to West Le Moyne Street; North Talman Avenue; a line 75 feet north of and parallel to West Le Moyne Street; and the alley next west of and parallel to North Talman Avenue,


to those of a RT4 Residential Two-Flat, Townhouse and Multi-Unit District and a
