BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the RM-6 Residential Multi-Unit District symbols and indications as shown on Map No. 7-F in the area bounded by

West Arlington Place; the public alley next west of and parallel to North Clark Street; the public alley next south of and parallel to West Arlington Place; and a line 361 feet east of and parallel to north Geneva Terrace.

To those of a B3-1 Community Shopping District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.





AMENDED ZONING AMENDMENT NOTIFICATION

Arlington Place. Your local Alderman asked the applicant to refrain from filing the amendment at that point in time in order to better understand the purpose of the filing. As such, the applicant did not file for the amendment at that time.

In accordance with the requirements for an Amendment to the Chicago Zoning Ordinance, specifically Section 17-13-0107, please be informed than on or about June 20, 2017, the undersigned will file an application for a change in zoning from RM-6 to B3-1 on behalf of Chicago Trattoria Associates, Inc., d/b/a Salvatore's Restaurant, for the property located at 525 W. Arlington Place.

The zoning amendment is necessary so that the applicant may obtain an Outdoor Patio liquor license to use the outdoor patio of the premises for liquor service and consumption. After issuance of the outdoor patio license, the applicant will file another application to amend the Chicago Zoning Ordinance requesting a change in zoning back to the RM-6 designation.




