#### **ORDINANCE**

BE IT ORDAINED BY THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the M1-2 Limited Manufacturing/Business Park District symbols and indicators as shown on Map No. 7-I in the area bounded by

North Rockwell Street; West Fletcher Street; the public alley next west of and parallel to North Rockwell Street; and the public alley next north of and parallel to West Fletcher Street.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

(A) Proposed Land Use:

The Applicant is seeking a zoning change in order to hold a Public Place of Amusement License (PPA) for a new concept business in an existing one-story manufacturing facility at the subject property. The existing building will be renovated and an addition will be added to accommodate the proposed use. The renovated building will contain a medium event venue (approx. 4,800 GSF), an artisan workshop (approx. 1,750 GSF), a meeting hall (approx. 4,250 GSF), and an open-air courtyard (approx. 2,300 GSF). The second story addition will contain approximately 2,300 GSF of office space and an 850 SF open-air rooftop patio. The addition will be Type-IIIB construction and will not exceed 30°-0" in height. No off-street parking is required or proposed for the new building. There will be no dwelling units.







(1) FIRST FLOOR PLAN
