
BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the RS3 Residential Single–Unit (Detached House) District symbols as shown on Map No. 14-H in the area bounded by:

A line 67 feet North of and parallel to West 58th Street; South Damen Avenue; West 58th Street; the public alley next West of and parallel to South Damen Avenue.

To those of a C2-1, Motor Vehicle-Related Commercial District

SECTION 2. This Ordinance takes effect after its passage and due publication.


