#### **ORDINANCE**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO: SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance is hereby amended by changing all of the RT4, Residential Two-Flat, Townhouse and Multi-Unit District symbols as shown on Map No. 6-I in the area bounded by:

West 24<sup>th</sup> Street; a line 201.55 feet West of and parallel to South Rockwell Street; the public alley next South of and parallel to West 24<sup>th</sup> Street; a line 226.55 feet West of and parallel to South Rockwell Street.

To those of an RM5, Residential Multi-Unit District

SECTION 2. This Ordinance takes effect after its passage and due publication.


