BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning
Ordinance is hereby amended by changing all of the RS2 Residential Single—Unit
(Detached House) District symbols as shown on Map No. 9-N
in the area bounded by:

A line 190.69 feet North of and parallel to West School Street; North Narragansett Avenue; a line 165.55 feet North of and parallel to West School Street; the public alley next West of and parallel to North Narragansett Avenue.

To those of an RT4, Residential Two-Flat, Townhouse and Multi-Unit District

SECTION 2. This Ordinance takes effect after its passage and due publication.


