ORDINANCE

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B1-2 Neighborhood Shopping District symbols and indications as shown on Map. No. 7-F in the area bounded by:

a line 411 feet north of West Fullerton Avenue; the alley next east of North Halsted Street; a line 336 feet north of West Fullerton Avenue; and North Halsted Street

to those of a B3-2 Community Shopping District and a corresponding use district is hereby established in the area above described.


SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.







In accordance with the requirements for an amendment to the Chicago Zoning Ordinance, please be informed that on or about July 19, 2017, the undersigned will file an application for a change in zoning from an B1-2 Neighborhood Shopping District to a B3-2 Community Shopping District on behalf of Parson's Lincoln Park, LLC, whose address is 3124 West Carroll Avenue, Chicago, Illinois 60612 (the "Applicant"), for the property located at 2435 North Halsted Street, Chicago, Illinois (the "Property"). The Property is owned by 2435 N Halsted LLC, whose address is 100 Sterling Lane, Northfield, Illinois 60093. The Applicant is the lessee of the Property.

The proposed zoning amendment application will allow the Applicant to renovate the existing, one story commercial building on the Property for use as a Parson's Chicken & Fish restaurant including a bar providing seating for patrons.

Please note that the Applicant is not seeking to rezone or purchase your property. The Applicant is required by law to send this notice because you own property within 250 feet of the property to be rezoned as described above.
