Unit District symbols and indications as shown on Map No.13-G in the area bounded by

a line 77.60 feet south of and parallel to West Winnemac Avenue; the alley next east of and parallel to North Ashland Avenue; a line 114.27 feet south of and parallel to West Winnemac Avenue; and North Ashland Avenue,

to those of a RM4.5 Residential Multi-Unit District and a corresponding uses district is


