BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

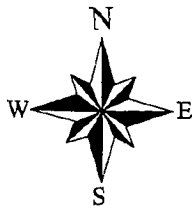
SECTION 1. Title 17, of the Municipal Code of Chicago, the Chicago Zoning Ordinance be amended by changing all the RS3 Residential Single-Unit (Detached House) District symbols and indications as shown on Map No.7-I in the area bounded by

a line 205.42 feet south of and parallel West Logan Boulevard; North Fairfield Avenue; a line 230.42 feet south of and parallel West Logan Boulevard; and the alley next west of and parallel North Fairfield Avenue,

to those of a RT4 Residential Two-Flat, Townhouse and Multi-Unit District and a corresponding use district is hereby established in the area above described.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.

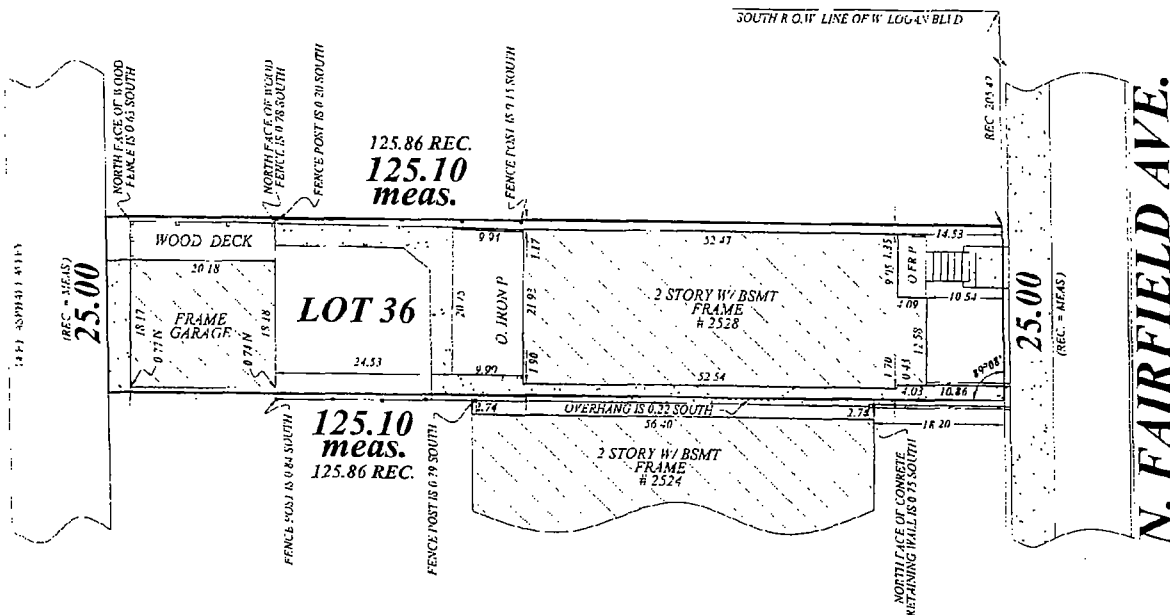

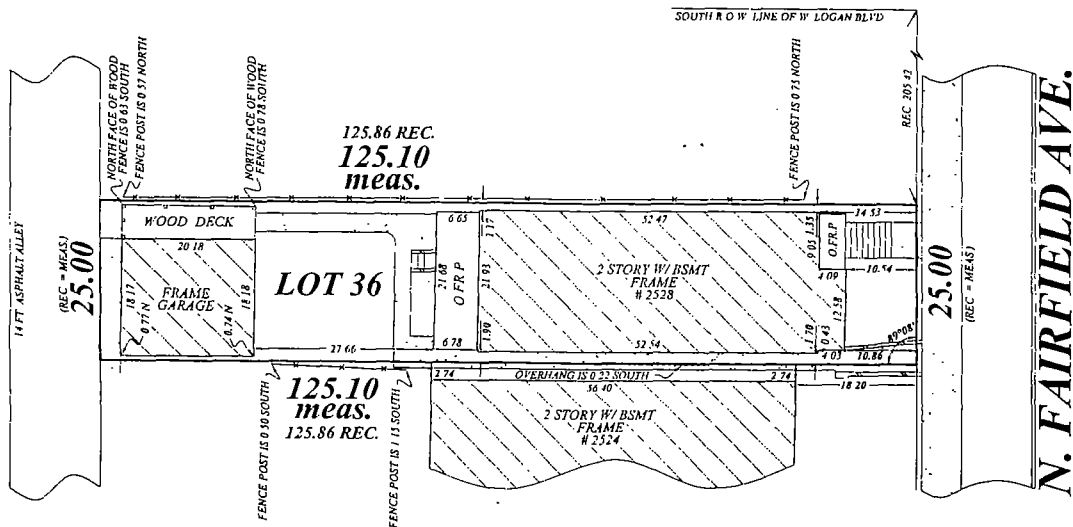


The Applicant is seeking to undertake a complete rehabilitation of the existing two-story (with basement) building, in order to repair recently sustained fire damage, at the subject site. The existing building presently contains a total of two (2) dwelling units and is *non-conforming* under the current Zoning Ordinance. The proposed rehabilitation plan calls for the buildout of the existing attic/dormer – above the second floor, and the establishment of one (1) additional dwelling unit within the basement – for a total of three (3) dwelling units at the property. The proposed zoning change is required, in order to bring the existing multi-unit (*non-conforming*) building into compliance under the current Zoning Ordinance, and to permit the proposed rehabilitation plan.
