#### **ORDINANCE**

#### BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

**SECTION 1**. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B3-2 Community Shopping District symbols and indications as shown on Map No. 3-H in the area bounded by

North Milwaukee Avenue; a line 350.00 feet south of and parallel to the south line of North Honore Street; the alley next northeast of and parallel to Milwaukee Avenue; and a line 425.04 feet south of and parallel to the south line of North Honore Street

to those of a B3-3 Community Shopping District.

**SECTION 2.** This ordinance shall be in force and effect from and after its passage and due publication.





LOT AREA: 8,850 SQUARE FEET

LAND USE: THE PROPERTY IS CURRENTLY IMPROVED WITH A FOUR-STORY BRICK BUILDING. THE PROPERTY WILL BE REHABBED TO PERMIT AN ADDITIONAL TEN (10) DWELLING UNITS ON FLOORS TWO THROUGH FOUR AS FOLLOWS: SIX (6) NEW UNITS ON THE SECOND FLOOR AND TWO (2) NEW UNITS EACH ON THE THIRD AND FOURTH FLOORS. THERE WILL BE A TOTAL OF EIGHTEEN (18) DWELLING UNITS. APPLICANT IS USING SECTION 17-10-0102-A OF THE CHICAGO ZONING ORDINANCE TO ELIMINATE A PARKING AND LOADING REQUIREMENT FOR THE BUILDING BECAUSE IT IS A CONTRIBUTING BUILDING WITHIN THE MILWAUKEE AVENUE CHICAGO LANDMARK DISTRICT.


