#### **ORDINANCE**

BE IT ORDAINED BY THE CITY COUNCIL OF THE CITY OF CHICAGO:

SECTION 1. Title 17 of the Municipal Code of Chicago, the Chicago Zoning Ordinance, is hereby amended by changing all of the B1-1 Neighborhood Shopping District symbols and indications as shown on Map No. 11-J in the area bounded by


a line 146.62 feet south and parallel to West Wilson Avenue; the public alley next east of and parallel to North Pulaski Road; a line 193.87 feet south of and parallel to West Wilson Avenue; and North Pulaski Road,

to those of a C1-1 Neighborhood Commercial District.

SECTION 2. This ordinance shall be in force and effect from and after its passage and due publication.


